The Consultancy Growth Network (“We”) is committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us.

Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. By completing the Consultancy BenchPress 2026 (the “Survey”) you are accepting and consenting to the practices described in this policy as well as consenting to our use of cookies in accordance with the terms of this policy.

## Overview

### Where it all began

The Wow Company started BenchPress in 2012, initially benchmarking agencies in the UK. They have grown that survey to be the largest of its kind for independent agency owners in the UK. The Wow Company worked with The Consultancy Growth Network to produce the first Consultancy BenchPress in 2020.

### Your data

By taking part in the Consultancy BenchPress survey or downloading the Consultancy BenchPress reports, you agree that The Consultancy Growth Network and/or The Wow Company will have access to your responses and can email you to share the results, trends, and insights derived from the survey. If you at any point don't wish to be contacted, you can unsubscribe at any time.

The more questions you complete, the more benchmarks you'll get out of it. However, if there's something you don't want to share with us, please skip the question. To publish the report, we consolidate the data and process it to put together the benchmarks and insights. Your individual answers are never shared outside of the organisations specifically mentioned above.

### GDPR

The General Data Protection Regulations, (GDPR), apply from 25 May 2018, creating consistent data protection rules across Europe. It applies to companies that are based in the EU and global companies that process personal data about individuals who are based in the EU. At The Consultancy Growth Network and The Wow Company, we shall ensure that we do not just observe the requirements of the GDPR for those Users based in the EU, but that we adopt the GDPR principles of transparency, control and accountability for all our Users across the globe.

The GDPR gives our Users certain rights when using our Services, which include the right to:

- be informed;

- access;
- rectification;
- erasure;
- withdraw consent;
- restrict processing;
- data portability;
- object

### **Our commitment to you is:**

We promise we will:

- Process data lawfully, fairly and in a transparent manner
- Collect data for specified, explicit and legitimate purposes
- Never sell or pass your data onto anyone else
- Ensure your data is processed and stored securely and is kept up-to-date

You will always:

- Have access to the data stored on you
- Be able to correct any inaccuracies in the data
- Be able to erase your data and restrict its processing
- Know we will erase any data no longer required, even if you haven't asked
- Know that as technology changes we will constantly review and update our processes to ensure we're always protecting your data

### **Processing your personal data: Legitimate Interest**

The processing of your personal data by The Consultancy Growth Network and/or The Wow Company or a third party may be undertaken if we have a legitimate interest to do so. In our case this includes:

1. For the purposes of providing information about our services and to monitor usage in order to improve those services from time to time.
2. Ensuring that any data is stored and transferred securely and in a way that protects against the unlawful use, destruction or loss of your personal data.

3. Sharing your personal information as part of a business sale, reorganisation or similar transaction.

### **Processing your personal data: By Consent**

Where we process your personal data by relying on your consent to do so, we shall ensure that such consent is:

1. freely given by you;
2. specific with regards to what processing we wish to undertake so that you are fully informed;
3. unambiguous and given by a clear affirmative action.

### **Information we collect from you**

We will collect and process the following data about you:

- The information you give us. This is information about you that you give us. This could be by filling in any forms on the Survey or by corresponding with us by phone, e-mail, or any other forms.
- Information we collect about you. Regarding each of your visits to our Survey we will automatically collect the following information:
  - technical information which may include: The Internet protocol (IP) address used to connect your computer to the Internet; browser type and version; time zone setting; browser plug-in types and versions and the operating system and platform.
  - information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from our Survey (including date and time), page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), methods used to browse away from the page, and any name, email address or phone number used to contact us.

The legal basis for this processing is our legitimate interests, namely monitoring and improving our Survey and enabling you to communicate with us and for us to send you reports and other material by request.

### **Cookies**

Our Survey uses cookies to distinguish you from other users of our Survey. This helps us to provide you with a good experience when you browse our Survey and utilise all of its features.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Generally, cookies work by assigning to your computer a unique number that has no meaning outside of the Survey. The cookies do not contain any personal information and cannot be used to identify you. They simply help us to provide you with a personalised user experience and also allows us to improve our website and advertising. ## Uses made of the information

The information you give to us, we will use in the following ways:

- to produce statistical analysis and reports, you will never be personally identified in these;
- for internal use and operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
- to communicate with you including to notify you about our services and any changes to our service;
- to communicate with you including to notify you about legal and regulatory body obligations and any changes that may be applicable to you;
- to ensure that content from our Survey is presented in the most effective manner for you and for your computer.

## Disclosure of your information

You agree that we have the right to share your personal information with:

- Selected third parties including:
  - business partners, suppliers and sub-contractors for the performance of any contract we enter into with them or you;
  - analytics and search engine providers that assist us in the improvement and optimisation of the Survey;
- We will disclose your personal information to third parties:
  - If we sell or buy any business or assets, in which case we will disclose your personal data to the prospective seller or buyer of such business or assets.
  - If we are under a duty to disclose or share your personal data to comply with any legal obligation or to enforce or apply our Terms of Use.

## Where we store your personal data

The data that we collect from you will be transferred to, and stored at, a destination inside the European Economic Area (“EEA”) by preference and wherever possible. For time to time personal data may be transferred, viewed and processed outside of the EEA. It will also be processed by staff operating inside the EEA who work for us or for one of our suppliers outside of the EEA. To process the survey data we use Survey Monkey. SurveyMonkey’s information systems and technical infrastructure are hosted within world-class, SOC 2 accredited data centres. Physical security controls the data centres include 24×7 monitoring, cameras, visitor logs, entry requirements, and dedicated cages for SurveyMonkey hardware. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All cloud services we use internally use industry-standard TLS (Transport Layer Security) and have up-to-date security measures and protocols.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our Survey or via email; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

### **Retaining and deleting your personal data**

Anyone also has the right to request deletion of all their personal data a business holds, or modification of their data if it's inaccurate or incomplete. GDPR requires the permanent removal or modification of any personal data. If you'd like your data permanently deleted or modified you can request to do so by emailing [privacy@consultancygrowthnetwork.com](mailto:privacy@consultancygrowthnetwork.com), we will respond to your request within 30 days.

Your personal data shall not be kept for longer than is necessary.

### **Your rights**

You have the right to ask us not to process your personal data for marketing purposes. We will usually inform you (before collecting your data) if we intend to use your data for such purposes. We will never disclose your information to any third party outside of The Consultancy Growth Network and The Wow Company for such purposes.

Our Survey may, from time to time, contain links to and from the website of our partner networks, advertisers and affiliates. If you follow a link to any of these websites, please note that these websites have their own privacy policies and that we do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data to these websites.

### **Access to information**

The Act gives you the right to access information held about you. Your right of access can be exercised in accordance with the Act and you can request access to the personal data we hold on you and verify the lawfulness of processing.
